With respect to above reference and subsequent school inspection in this regard, I hereby convey the grant of Recognition to **Eklavya Model Residential School Boripada, Tal. Trimbakeshwar Dist. Nashik c/o Government English Medium Residential School Mundhegaon Tal. Igatpuri Dist. Nashik.422403** for class VI to X standard in compliance to guidelines issued by the Ministry of Tribal Affairs, Government of India dated 13 Nov.2020

The above recognition is subject to the following conditions:-

1. The temporary recognition accorded to the school is valid from the academic year **2024 to 2029** and is to be renewed at an interval of every **05** years.
2. The grant of recognition is available initially for classes VI to VIII standard and to be extended for Secondary /Senior Secondary classes subsequently in due course of time.
3. The school shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the State RTE Act,2009.
4. The school shall admit in class VI in accordance with the guidelines issued by NESTS in November 2020 with the mentioned reservation criteria.
- 5.The school shall maintain a separate bank account for the purpose of reimbursement. APPENDIX - XV
6. The school shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.

7. The school shall not deny admission to any child, -
 - a. For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
 - b. On the ground of religion, caste or race, place of birth or any of them.
8. The school shall ensure that,-
 - a. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - b. No child shall be subjected to physical punishment or mental harassment.
 - c. No child is required to pass any board examination till the completion of elementary education.
 - d. Inclusion of students with disabilities/ special need as per provision of the RPWD 2016
 - e. The teachers are recruited with minimum qualifications as laid under the guidelines of NCERT/ CBSE .
 - f. The teachers perform his duties specified guidelines of NCERT/ CBSE.
9. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
10. The school shall maintain the standards and norms as specified by CBSE.
11. No unrecognized classes shall run within the premises of the school or outside in the name of school.
12. The school building plan must have been approved by the current rules or G. Os. The school building or other structures and the grounds are used only for the purposes of education and skill development. Construction work within the compound should not be carried out in school working hours and safety measures in all respect are under whole responsibility of the managements.
13. The school is run by a society registered under the The Society Registration Act 1860(Act under with Society is registered), or a public trust constituted under any law for the time being in force.
14. The school is not run for profit to any individual, group or association of individuals or any other persons.
15. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared.
16. The school shall furnish such reports and information as may be required by the competent authority from time to time and shall comply with such

instructions of the State Government or the competent authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.

17. Marathi, Hindi, English (language subject) shall be taught as a subject from in standards upto X in all schools notified by CBSE from academic session recognition is granted. APPENDIX - XV

18. The school shall abided by the provisions of the CBSE Affiliation Norms.

19. The certificates of recognition issued by the department shall be subject to the fulfillment of deficiencies if any pointed out by the department at any stage/ time.

20. The management shall rectify the deficiencies pointed out in infrastructure or administration by the authorities.

21. The management shall apply for renewal of recognition three months before the expiry of this order to this Member Secretary, Maharashtra Tribal Public School Society Nashik ,Adivasi Vikas Bhavan, First Floor, Gadkari Chowk Old Agra Road, Nashik M.S. 422002.

22. The management shall follow the directions issued by the Government/ Department form time to time keeping in view of the safety and security of the children and the overall administration of the school.

23. The recognition shall be withdrawn if any contravention of the provisions of the Act, Rule or the conditions of recognition are found and proved.

24. The school management shall have to full responsibility if any court cases arises this regard. The management is not entitled to seek affiliation to other Board without obtaining NOC from the Member Secretary, Maharashtra Tribal Public School Society Nashik ,Adivasi Vikas Bhavan, First Floor, Gadkari Chowk Old Agra Road, Nashik M.S. 422002.


Madam/ Sir,

This is with reference to your letter No. NESTS/Civil/ Location Approval/154/ 2021-22 dated 22.01.2022 regarding sanction of new EMRSs. The same has been examined and the approval of competent authority is accorded for establishment of EMRSs at **6 locations** as per the list at **Annexure** with the following conditions:

- The identified land shall be transferred in the name of the State EMRS Society/ Tribal Welfare Department by the concerned State Government.
- The construction of the approved school will be undertaken construction only through the agency assigned by the NESTS.
- The cost of construction of the schools shall not exceed the unit cost approved by the competent authority as per the category of the school.
- The pre-construction activities including handing over of land, survey and soil investigation, preparation of MLP & DPR, calling of tenders and award of work by Construction Agency is envisaged to be completed in 5 to 6 months and the period stipulated for completion of construction work by the construction agency is 18 months. The same may be adhered to and the construction agency be informed accordingly.
- The location of the schools cannot be changed unless approved by the Ministry.


Please refer your letter number P. School-2020/F.No.57(C)desk.6(7)/2919 dated 12.04.2022 regarding clarification for schools to be made functional. As stated, 14 schools were proposed for the state to start from the AY 2021-22. However, out of 14 schools only 06 schools have received the office order from NESTS to be made functional and 05 Schools are yet to receive the order.

2. The matter has been examined and it is stated that sanction orders are already issued for 06 EMRSs i.e EMRS Dhanora , Shahada (Mohida), Taloda (Kharwad), Peth (Devgaon), Boripada & Sakri whereas 02 Schools are yet to be sanctioned i.e.EMRS, Vikramgad and Wada.

3. In view of the above, 06 schools may be made functional subject to the following conditions:

- i. School should be made functional in a Govt. building only.
- ii. Adequate regular staff should be available. In case of unavailability of regular staff, guest teachers can be hired.
- iii. Contractual teachers should not be appointed in any case.

This issues with the approval of competent authority.


